According to the relevant provisions of Article 7, 8 and 14 of “Niğde Ömer Halisdemir University Graduate Education, Training and Exam Regulation” and the Articles 5, 6, 7, 8 and 9 of “Regulation for Admitting International Students to Second Cycle Programs of Niğde Ömer Halisdemir University”, Graduate School of Educational Sciences of Niğde Ömer Halisdemir University will admit Foreign Students to Master’s (with thesis) and Doctorate Programs to the below mentioned disciplines for 2020-2021 Academic Year.

**Required Documents for Application:**

(1) Applicants may apply together with the following documents in person, by mail / cargo or by e-mail:

- a) Application form,
- b) For the master's programs, a certified copy of the undergraduate diploma or graduation document from the foreign delegations and its certified Turkish translation,
- c) For qualification in art / doctoral programs, a copy of the bachelor's and master's degree diploma or graduation certificate approved by the foreign delegations and certified Turkish translation from a candidate applying with a bachelor's degree and master's degree to a doctoral program respectively,
- ç) Certified copy of the transcript and its certified Turkish translation,
- d) Documents showing foreign language proficiency for qualification in art / doctoral programs. Candidates who do not have a foreign language score for applying to qualification in art / doctoral programs must provide foreign language requirement before the qualifying examination of the relevant program.

(2) Candidates who apply for qualification in art / doctoral programs must have at least 55 points from the central foreign language exams made by the Higher Education Council (YÖK) or Student Selection and Placement Centre (ÖSYM) in Turkey or an equivalent score of an international foreign language exams accepted by the Higher Education Council. Candidates who have completed a bachelor's or master's degree in a foreign language that the department deems relevant they shall be exempted from the foreign language requirement by the decision of the department and the approval of the Graduate School Board.

### **Application Requirements:**

- (1) To be graduated from undergraduate or graduate programs of universities;
  - a) Those who have acquired citizenship of the Republic of Turkey when they are foreign citizens or the ones with dual citizenship in this situation,
  - b) Those who are citizens of the Republic of Turkey and complete undergraduate education in foreign countries,
  - c) Those who are citizens of a foreign country may apply for international student status.
- (2) The institutions where the candidates have graduated must be recognized by the Higher Education Council. Students who have graduated from the institution that is not recognized by the Council of Higher Education will be dismissed from the related institute even if they have registered.
- (3) Special requirements of the Master's (with thesis) programmes are as follow:
  - Educational Administration:** Graduates of Faculty of Education,
  - Guidance and Psychological Counselling:** Graduates of Guidance and Psychological Counselling of Faculty of Education,
  - Curriculum and Instruction:** Graduates of Faculty of Education,
  - Music Education:** Graduates of Music Education of Faculty of Education or graduates of disciplines related to music.
  - Mathematics Education:** Graduates of Mathematics Education of Faculty of Education,
  - Science Education:** Graduates of Science Education, Biology Education, Physics Education, and Chemistry Education of Faculty of Education,
  - Social Studies Education:** Graduates of Social Studies Education of Faculty of Education.
- (4) Special requirements of the doctorate programmes are as follow:
  - Science Education:** Graduates of master's programmes from Science Education, Biology Education, Physics Education, and Chemistry Education,
  - Social Studies Education:** Graduates of master's programmes from Social Studies Education.

### **Evaluation of Applications:**

- (1) Application files of the applicants to graduate programs of our Institute will be evaluated as a whole by the Board of Division of the relevant program and admission of competent applicants will be determined upon the resolution of the Graduate School Board.
- (2) Candidates who apply to the related institute based on the bilateral agreements and who apply directly to the relevant faculty member at the department can be accepted as non-quota students to the graduate programs with the decision of the department and the approval of the Graduate School Board. Candidates who are admitted must have the exact registration and course registration procedures at the dates announced by the institute website in the following semester.
- (3) The grade conversion table of the Higher Education Council is taken as basis for the hundred system equivalents of grade average of the candidates organized according to the graduation grade average system.
- (4) Except for candidates graduating from a higher education institution in Turkey, and certifying C1 level of Turkish knowledge from TÖMER, NÖHÜTÖMER or Yunus Emre Institute, Turkish proficiency of candidates who enrol in programs where the medium of education is Turkish, is evaluated by Niğde Ömer Halisdemir University Turkish Language Teaching Practice and Research Centre (TÖMER). Candidates who are inadequate in the Turkish language are considered to be on leave for two semesters to learn Turkish. At the end of this period, the ones with the C1 level Turkish Proficiency Certificates submit documents to the Institute at the beginning of the relevant semester and start their education. Those who

cannot submit the C1 level Turkish Proficiency Certificate after the period given from the students who are accepted or who cannot succeed in the Turkish proficiency exam which will be done by NÖHÜTÖMER, will be granted two additional semesters. Students who are deemed to be inadequate in Turkish level at the end of the additional period will be dismissed from the relevant Institute.

(5) Foreign language compulsory preparatory program is applied to students enrolling in graduate programs that offer education and training in a foreign language. Niğde Ömer Halisdemir University School of Foreign Languages Preparatory Program Education and Examination Regulations shall be applied in the compulsory preparatory program.

(6) Those who are admitted to the graduate programs in spring semester but have to attend compulsory preparatory program, do final registration and course registration for the fall semester on the dates announced on the website of the institute.

(7) Applicants who do not have the application requirements shall not be evaluated.

### **Announcement of the Results and Final Registration:**

(1) Application results are announced online on the website of the Graduate School.

(2) Prospective students who are accepted to the programmes are sent an acceptance letter by the Graduate School.

(3) Students should pay the tuition fee determined by the Board of Directors of the University within the framework of Council of Ministries decision, unless they are exempted from payment upon the bilateral agreements.

(4) Registrations are carried out by Student Affairs Department of the Graduate School between the dates announced on the Institute website.

### **(5) Required Documents for Final Registration:**

a) Final registration form,

b) Original copy of the diploma or graduation document, together with a certified copy translated into Turkish by sworn translators,

c) Original copy of the transcript, together with the certified copy translated into Turkish by sworn translators,

ç) Certified passport,

d) Six photographs taken in the last six months,

e) Certificate of tuition fee payment\*\*,

(6) Students who have the right to final registration cannot register if the required documents are not complete.

(7) After the final registration, the registration of the students who have not obtained the residence permit for the purpose of education from the Provincial Directorate of Migration Administration will be deleted.
