## **Required Documents for Application:**

- 1. Application form,
- 2. Approved copy of Bachelor's degree diploma from foreign representative office,
- 3. Approved copy of the transcript,
- **4.** ALES, GRE or GMAT result document (if available), (It is not required for candidates applying to the Department of Fine Arts Education, Discipline of Music Education).

## **Application Requirements:**

- 1. Foreign language proficiency is not required for those who received their Bachelor's or Master's degree in a domestic or foreign program with the language of education as English, German or French.
- **2.** In the case that a candidate who does not have a score from ALES, GRE or GMAT is admitted to the program, he is required to enter the ALES exam before completing the program.

## **Evaluation of Applications:**

- -Application files of the applicants to graduate programs of our Institute will be evaluated as a whole by the Board of Division of the relevant program and admission of competent applicants will be determined upon the resolution of the Institute Board of Directors.
- -Candidates certifying their scholarship from Turkish Government or their native country's government and applying to be a graduate student are exempted from the quotas, and admitted as students to programs upon the resolution of the Institute Board of Directors.
- Candidates applying to graduate programs within the framework of the bilateral agreements of Ömer Halisdemir University are exempted from the quotas, and admitted as a student, upon the opinion of Head of the Division of relevant program, resolution of the Institute Board of Directors, and approval of the Senate
- Students should pay the tuition fee determined by the Board of Directors of the University within the framework of Council of Ministries decision, unless they are exempted from payment upon the bilateral agreements.
- Except for candidates graduating from a higher education institution in Turkey, and certifying A or B level of Turkish knowledge from TÖMER, Turkish proficiency of candidates

is evaluated by Ömer Halisdemir University Turkish Language Teaching Practice and Research Centre (TÖMER). Candidates with unsatisfactory Turkish knowledge can start their graduate education in the following semester after they get A or B level of Turkish knowledge from the examinations of Ömer Halisdemir University Turkish Teaching Practice and Research Center TÖMER by participating into the Turkish courses. Candidates have two semesters at most to learn Turkish. Students who cannot succeed at the end of this period will be given two extra semesters. Students who fail to get these scores at the end of the additional period will be dismissed from the Graduate School.

#### **Announcement of the Results and Registration:**

- 1. Application results are announced online on the website of the Graduate School.
- **2.** Prospective students who are accepted to the programmes are sent an acceptance letter by the Graduate School.
- **3.** Registrations are carried out by Student Affairs Department of the Graduate School between the dates announced on the Institute website.
