Documents Required For Application:

- **1.** Application Form.
- 2. Copy of undergraduate/graduate diploma certified by Foreign Delegations.
- 3. Copy of transcript certified by Foreign Delegations.
- **4.** Document showing the result of ALES (The Entrance Examination for Academic Staff and graduate Studies), GRE or GMAT (if any).

Common Conditions Required for Application:

- **1.** Foreign language proficiency is not required for applicants graduating from the undergraduate or graduate programs where medium of instruction is English, French or German.
- **2.** Applicants who do not have any of the documents showing the result of ALES, GRE or GMAT are required to take ALES until they have completed their graduate studies in the case that they are accepted to the programs.

Evaluation of Applications:

- -Executive Board of the related Department evaluates the application files of candidates applying to the graduate programs of the Institute as a whole and admission of candidates is finalized by the resolution/decision of Executive Board of related Graduate School.
- -Those who apply to graduate studies by documenting scholarship of Republic of Turkey or their own states shall be accepted to the graduate programs other than the quota as per the decision of the Executive Board of the Graduate School.
- -Those who apply to graduate studies on the basis of bilateral agreements in which Ömer Halisdemir University is a party shall be accepted to the graduate programs other than the quota pursuant to the opinion of the related Head of Department, decision of the Executive Board of the Graduate School and approval of the Senate.
- Those who are not exempt as per bilateral agreements shall be obliged to pay the fees specified by the Executive Board of the University within the framework of the Cabinet decision.

- Ömer Halisdemir University Turkish Language Teaching Application and Research Centre evaluates whether candidates are competent in Turkish to conduct graduate studies except for those who have a certificate granted by TOMER showing their competency in Turkish "level A or B" and graduated from a higher education institute in Turkey. Those who do not have Turkish competency may continue their graduate studies for the following semester on condition that they receive level A or B in the examinations after participating in the Turkish language courses conducted by NUTOMER. Candidates are granted with a period of maximum two semesters to learn Turkish. Those who are not successful at the end of this period are dismissed from the Graduate School.
- -The candidates who apply to the Department of Fine Arts Education of Music Education Master's Program with Thesis shall be subjected to an interview. The applicants should be present on the date and place specified for the interview. Applications of the candidates who do not attend the interview will be considered invalid.
- Candidates who will apply to the Discipline of Science Education should have a bachelor degree at Science Teaching.

- 1. Application results shall be announced on the website of the Graduate School.
- **2.** A letter of acceptance is sent to the entitled candidates by the Graduate School.
- **3.** Registration is carried out by the Student Affairs Unit of the Graduate School on the dates announced on the web page.
