TERMS of TRANSFER

1. The student should have successfully completed at least one semester at a Higher Education Institution and fulfill the requirements of the program s/he will be transferred.
2. Applicants who do not have any of the documents showing the result of ALES, GRE or GMAT are required to take ALES until they have completed their graduate studies in the case that they are accepted to the programs.

The student should be proficient in Turkish in order to continue his/her education at Niğde University Graduate School of Natural and Applied Science. Niğde University Turkish Language Teaching Application and Research Centre (NUTOMER) evaluates whether candidates are competent in Turkish to conduct graduate studies except for those who have a certificate granted by TOMER showing their competency in Turkish "level A or B" and graduated from a higher education institute in Turkey. Those who do not have Turkish competency may continue their graduate studies for the following semester on condition that they receive level A or B in the examinations after participating in the Turkish language courses conducted by NUTOMER. Candidates are granted with a period of maximum two semesters to learn Turkish. After this period for an additional period of two semesters is given to students who fail. Dismissed if deemed inadequate by the Institute of Turkish cut the extension period.)

4. Residential permit for educational purposes,
5. 6 photos (taken within the last six months),
