For the students are approved to the programs taught In **TURKISH**, Turkish proficiency exam shall be held at the Faculty of Architecture Rooms on **October 6<sup>th</sup>**, **2024** at **09:30** by the Niğde Ömer Halisdemir University Turkish Language Teaching Application and Research Center (NÜTÖMER) for those who are not graduated from universities in Turkey and do not have Turkish competence certificate (Level C1) from Turkish Teaching Center (TÖMER), NÖHÜTÖMER or Yunus Emre Institue, in accordance with the Article 8-(4) of Directive on **Niğde Ömer Halisdemir University Directive On International Student Admission To The Graduate Programmes**.

For the students are approved to the programs taught in **ENGLISH**, English Language Preparatory program is mandatory. The student who has to attend the preparatory foreign language courses may begin their education through being exempt from preparatory foreign language programme:

- i) The student should be successful at the proficiency exam held by the School of Foreign Languages at the beginning of the academic year on a date previously stated in the academic calendar of preparatory foreign language programme,
- ii) The student should evidence that s/he has got minimum 60 points from YDS (the Foreign Language Examination) or an equivalent score in other valid examinations (http://www.yok.gov.tr/documents/10279/30814109/EsdegerlikTablosu.pdf/) adopted by the Interuniversity Board, all points to be acquired from the exams held within the last three years,
- iii) Provided that Executive Board of the School of Foreign Languages decides in favour of his/her exemption, the student should have attended the preparatory programme of another university and successfully completed the preparatory programme education within the last three years at a level set forth by the University,
- iv) Provided that Executive Board of School of Foreign Languages decides in favour of his/her exemption, the student should have been successful at foreign language proficiency exam for preparatory class held by another university where the student was previously registered within the last three years at a level set forth by the University,
- v) The student should evidence that s/he completed his/her secondary education at an institution of a natively English speaking country, to which the citizens of the country also attend,
- vi)The student should graduate from a programme of a university where the education is carried out in English, either at home or abroad
