

APPLICATION REQUIREMENTS

1) Foreign nationals (provided they have not attended or graduated from secondary schools (high schools) in Turkey [excluding foreign nationals who have completed their entire high school education at embassy schools or international private educational institutions listed in the MOBIS system, as well as foreign nationals who have come to our country under projects administered by the Ministry of National Education or the Council of Higher Education])

2) Those who were Turkish citizens by birth but lost their Turkish citizenship by obtaining permission from the Ministry of the Interior to renounce it, as well as those who can document that they hold a Blue Card issued to individuals who have lost their Turkish citizenship upon request (provided they have not attended or graduated from secondary schools (high schools) in Turkey or the Turkish Republic of Northern Cyprus) (It is advisable for applicants applying for admission quotas from abroad to review Article 7 of Law No. 5901 on Turkish Citizenship.)

3) Individuals who acquired Turkish citizenship through naturalization after holding foreign citizenship / dual nationals in this situation (provided they have not attended or graduated from secondary schools (high schools) in Turkey or the Turkish Republic of Northern Cyprus)

4)) Turkish citizens who completed their entire secondary education (high school) in a foreign country other than the TRNC (including those who completed their entire secondary education [high school] at Turkish schools established under the Ministry of National Education in a foreign country other than the TRNC)

5) Applications from TRNC nationals will be accepted provided they have not attended or graduated from high schools in Turkey or from high schools in the TRNC that follow the Turkish curriculum, and provided they meet the criteria specified in the application and admission guidelines approved by the Higher Education Council for higher education institutions, or hold a GCE AL or TR-YÖS certificate.

APPLICATIONS ARE ACCEPTED.

1) Turkish citizens who have completed their entire secondary education (high school) in Turkey or the Turkish Republic of Northern Cyprus,

2) TRNC nationals or dual nationals (one of whose nationalities is TRNC) who have completed their entire secondary education (high school) in TRNC high schools and who have or will obtain GCE AL results, or TRNC nationals who completed their entire secondary education (high school) in a foreign country, except for those who meet the criteria specified in the application and admission guidelines approved by the Higher Education Council for TR-YÖS or higher education institutions),

3) Dual citizens whose one citizenship is Turkish (those who completed high school in Turkey),

4) Turkish citizens or dual nationals whose first citizenship by birth is Turkish, as defined in Article 7 of the Turkish Citizenship Law No. 5901, who are enrolled in schools affiliated with embassies in Turkey or in foreign high schools located in Turkey

5) a) TRNC citizens and individuals who have renounced Turkish citizenship or hold a Blue Card who are currently enrolled in or have graduated from secondary schools (high schools) in Turkey and the TRNC

b) Foreign nationals who are currently enrolled in or have graduated from secondary education (high school) institutions in Turkey (excluding foreign nationals who completed their entire high school education at embassy schools or international private educational institutions listed in the MOBIS system, as well as foreign nationals who came to our country under projects administered by the Ministry of National Education or the Higher Education Council)
