

**NIGDE UNIVERSITY**  
**DIRECTIVE FOR FOREIGN STUDENT ADMISSION TO ASSOCIATE AND**  
**UNDERGRADUATE PROGRAMMES**

**PART ONE**

**Aim, Scope, Legal Basis and Definitions**

**Aim and scope**

**ARTICLE 1-** (1) This Directive aims to regulate registration and admission criteria, and applications to Nigde University within the scope of the quotas for foreign students to department and programmes of the faculties and schools determined by The Council of Higher Education.

**Legal Basis**

**ARTICLE 2-** (1) This Directive is based on;

- a) the Article 7 of The Law no 2922 on Foreign Students Studying in Turkey, dated 14/10/1983,
- b) the subparagraph (E) of the Article 6 of the Regulation on Foreign Students Studying in Turkey, published in the Official Gazette, dated 30.04.1985 and numbered 18740
- c) the documents of the Higher Education Council, dated 27/1/2010 and numbered 06-383-3269 and 06-383-3270,
- d) the document of the Higher Education Council, dated 19/2/2010 and numbered 06-800-6165, and that dated 23/3/2010 and numbered 06-1489-10212,
- e) the document of The Higher Education Council, dated 6/6/2011 and numbered 3733-023747,
- f) the document of the Higher Education Council, dated 26/8/2011 and numbered 5658-037298.

**Definitions and Abbreviations**

**ARTICLE 3-** (1) For the purpose of this Directive:

- a) Student shall mean a foreign student graduating from a school which is equal to Turkish high schools, and Turkish citizens who have completed the last three years of their secondary school education in a foreign country except for TRNC, and TRNC citizens who reside and have completed their secondary school education in TRNC, and have attended GCE AL,
- b) Rector shall mean the Rector of Nigde University,
- c) Rectorate shall mean the Rectorate of Nigde University,
- ç) Senate shall mean the Senate of Nigde University,
- d) University shall mean Nigde University.
- e) NÜTÖMER: refers to the Nigde University Turkish Language Teaching Application and Research Centre.

**PART TWO**

**General Provisions**

**ARTICLE 4-** (1) The tuition fee to be received from foreign students per each year is determined by the Executive Board of the University in line with the provisions of relevant laws, within the range of the amount defined by The Board of Ministries.

**ARTICLE 5-** (1) In the event that there are no applications or quotas are not filled completely for a department, these quotas shall not be added to the quotas of other departments.

**ARTICLE 6-** (1) Student can only apply for five (5) different programmes.

**ARTICLE 7-** (1) Students who are registered are reported to the Higher Education Council and Provincial Directorate of Security.

**ARTICLE 8-** (1) Those who are;

- a) Foreign citizens,
- b) The children of former Turkish citizens who renounced their citizenship by approval of Ministry of Internal Affairs, and their under-age children who are recorded on the document of renunciation of Turkish citizenship, and who hold a document demonstrating that they are

entitled to use the rights defined in the Law no 5203, published in the Official Gazette dated 06.07.2004 and numbered 25514,

c) Dual citizens, who are foreign citizens by birth but acquired Turkish citizenship as well,

d) Those who are the citizens of Republic of Turkey and continued and completed the last three years of secondary education in a foreign country other than Turkish Republic of Northern Cyprus before 01.02.2013 (including the ones who completed their whole duration of secondary education at Turkish schools founded under the control of Ministry of National Education in a foreign country other than Turkish Republic of Northern Cyprus) and the candidates who started secondary education in a foreign country after 01.02.2013 and completed their whole duration of secondary education in a foreign country other than Turkish Republic of Northern Cyprus through admission quota for foreign students

(including the ones who completed their whole duration of secondary education at Turkish schools founded under the control of Ministry of National Education in a foreign country other than Turkish Republic of Northern Cyprus)

e) TRNC citizens who reside and have completed their secondary school education in TRNC, and have attended GCE AL are eligible for application.

(2) Those who are,

a) Turkish citizens (except for those who have completed the last three years of their secondary school education in a foreign country other than TRNC),

b) TRNC citizens (except for those who have completed their entire secondary school education in TRNC and have attended GCE AL),

c) Dual citizens, one of them being Turkish (except for those who have completed the last three years of their secondary school education in a foreign country other than TRNC),

d) Dual citizens, one of them being TRNC (except for those who have completed their entire secondary school education in TRNC and have attended GCE AL),

e) Those who are the citizens of Republic of Turkey and study at schools which are under the constitution of embassies in Turkey and at foreign high schools in Turkey, or those with double nationalities who hold natural born citizenship of Republic of Turkey as per the provision specified in Article 7 of Turkish Citizenship Law No. 5901 “(1) A child born to a Turkish mother or father within the unity of marriage either in Turkey or abroad is a Turkish citizen” (except for those who fulfil the conditions specified at the subparagraph (b) of the Article 1)

f) Turkish citizens who have completed their secondary school education in TRNC are not eligible for application.

### **PART THREE**

#### **Application, Documents Required, Evaluation, Education-Training Criteria and Registration**

##### **Application**

**ARTICLE 9-** (1) Quotas for foreign students to be admitted to the University are determined by the Senate of the University taking the opinions of relevant academic units, and are announced on the web page of Registrar’s Office (<http://www.oidb.nigde.edu.tr>) after the quota announcement on the web page of The Higher Education Council.

(2) The application shall be submitted to the Registrar’s Office on the web site between the specified dates.

##### **Documents Required for Application**

**ARTICLE 10-** (1) The following documents are required for application;

a) Application form for foreign student admission (accessible on the web page of our University),

b) High School Diploma: Notarized Turkish or English copy of high school diploma,

c) Official Transcript: Official transcript certified by the high school directorate, documenting the courses and scores received by the applicants in high school (if not Turkish,

notarized Turkish translations of the transcripts must be enclosed and submitted with the transcript).

d) Photo

e) The candidates applying to the undergraduate program shall submit the documents indicating to the results of international exam, national exam, high school final exams and any of the Admission Exams for International Students Conducted by Universities in Turkey. Only one of these documents shall be applicable (See Table 1).

f) The exams applicable for the Admission of foreign students shall be valid for two years. The exams that correspond to the high school final exams (Abitur, International Baccalaureate, GCE, Tawjihi) have no time restriction.

### **Evaluation of Applications**

**ARTICLE 11-** (1) The committee formed by the Rectorate shall evaluate the preferences of international or foreign students, and their placement procedures. The applications of the students that do not meet the requirements shall not be evaluated.

(2) During the evaluation of the students applying to the quota and their placement to the undergraduate programs, either one of the exam results obtained from international exam, national exam, national high school exam, or the high school diploma grade shall constitute the basis. For the candidates that take the Admission Exams for International Students Conducted by Universities in Turkey, the result of this exam shall be applicable. Only diploma grade shall constitute the basis for the placement to associate degree programs.

(3) The exams that shall be applicable for the placement of the students to international student quota of the university are stated in Table 1.

(4) The evaluation for the placement of students to the international student quota of the university shall be conducted out of 100 points in total and separately according to the below stated order of priority

a) For the students with international exam result, 70% of this exam and 30% of high school diploma grade;

b) For the students with national exam result, 70% of this exam and 30% of high school diploma grade;

c) For the students with the result of Admission Exams for International Students Conducted by Universities in Turkey, 70% of this exam and 30% of high school diploma grade

ç) For the students with the result of central high school final exam, 70% of this exam and 30% of high school diploma grade

d) For the placement through diploma grade, 100% of the diploma grade shall constitute the basis.

(5) The grades that shall constitute the basis for placement shall be organized as 5 (five) different lists that are ranked for each evaluation in reverse numerical order. The placement to the quota shall be carried out basing on the order of priority list within the quota restrictions. In cases where the grades are equal, the ages of the candidates shall be taken into consideration. The ages shall be listed in reverse numerical order. After the final registration, the students on the waiting list may be announced for the available quota.

(6) Evaluation of the applications submitted to the Universities' departments that admit students through special skills tests shall be conducted basing on the criteria stated in application, registration and Admission guide prepared for special skills tests by the related faculty/school.

(7) The number of the accepted students in the same country shall not exceed 20% of the total quota of programs in the faculty or school. In cases where still available quota exists, the limit may be increased as much as the available quota

### **Announcement of the results and registration**

**ARTICLE 12-** (1) Application results are announced online on the website of the University.

(2) Prospective students who are accepted to the University are sent an acceptance letter by the Rectorate.

(3) Registrations are carried out by University Student Affairs Department between the dates announced on the University website.

### **Necessary documents for the registration**

**ARTICLE 13-** (1) Documents listed below are required for the registration:

a) Original copy of high school diploma and the “Certificate of Equivalence” showing that it is equivalent to the diplomas taken from Turkish high schools (this document shall be taken from the Turkish Embassy or Consulate in their countries or from the Ministry of National Education of Republic of Turkey),

b) Original copy of passport and the photocopy of its notary-certified Turkish translation,

c) Bank receipt showing that the tuition fee has been paid (at the amount announced and to the relevant bank announced),

ç) “Student Visa” to be got from their countries’ or the closest Turkish foreign missions for the students outside Turkey; and from the Provincial Directorate of Securities for students in Turkey, except for those who have come to Turkey with visa or taken the advantage of visa exemption and have right to have Bachelor’s/ Associate degree education while staying in Turkey with residence permit

d) Original copy of internationally valid certificate of competence of Turkish as Foreign Language certified by Turkish Embassy or Consulate in their countries,

e) Copy of residence permit (shall be received from Provincial Security Directorate by submission of student certificate to be issued after final registration),

f) Passport photograph taken within the last 1 year – 6 copies,

g) Original copy of transcript and its true copy in English or Turkish certified by Turkish Embassy or Consulate in their countries.

### **Proficiency levels of Turkish language**

**ARTICLE 14-** (1) Proficiency levels of Turkish language are stated below:

**C1, C2 Level:** Student’s level of Turkish language is adequate. Student can start receiving education.

**B1, B2 Level:** Student’s level of Turkish language can improve in a short span of time. Student can start receiving education, but he/she should take Turkish courses. Student must increase his/her level of proficiency of Turkish language to C1, C2 until the graduation.

**A1, A2 Level:** Student’s level of Turkish language is inadequate. Apart from the ones applying to programmes offering foreign language education, prospective students –after having their final registration to the programme where they are accepted – shall be granted 1-year leave of absence and shall take Turkish language courses and increase their level of this language to C1,C2 or B1,B2, then they can start their education.

(2) Level of Turkish language proficiency shall be specified through Turkish Proficiency Exam held by NÜTÖMER

(3) The candidates with B1, B2 and A1, A2 levels of Turkish proficiency shall be subject to the Turkish Proficiency Exam at the end of the first week following the start of Education-Training period in fall semester.

(4) Among the students that are enrolled to the departments with foreign language preparation program, those that have B1, B2 and A1, A2 levels of Turkish proficiency shall start their education. However they are liable to have a level of C1, C2 Turkish proficiency. Unless the students to graduate document that they have a C1, C2 level of Turkish, they shall not be able to graduate until providing regarding evidence.

(5) The related committees shall resolve that the students with A1, A2 level of Turkish proficiency shall be regarded as on leave for a year by the departments/programs they are enrolled to. Those who have attained C1, C2 or B1, B2 level of Turkish Proficiency Certificate at the end of first year should submit the certificate to *the related Faculty/School* before the beginning of the academic year. The Registrar’s Office is notified about the submitted documents by *the related Faculty/School*. Those who do not submit the certificate proving C1, C2 or B1, B2 level of Turkish Proficiency at the end of the first year or are not successful at the Turkish Proficiency Exam conducted by NÜTÖMER *shall be granted an extension of one year. Those who are not successful at the end of extension shall be dismissed from the University.*

*The students who are placed within the scope of Turkey scholarship can benefit from extension on condition that they continue their education with their own resources.*

(6) Equivalence of the Turkish proficiency certificate attained by the students from other institutions and organizations shall be determined by NÜTÖMER.

### **Language of education and foreign language preparatory education**

**ARTICLE 15-** (1) Language of education at our University is Turkish. Students having been accepted to the University are subject to the provisions of Niğde University Directive on Associate and Undergraduate Education and Training and Examination for their common compulsory English language courses at the faculties and schools, whereas they are subject to the provisions of Niğde University Directive on Foreign Language Preparatory Programme Education and Training and Examination.

(2) ) After receiving preparatory education, students with B1, B2 or C1, C2 Turkish language proficiency levels shall start receiving education, whereas students with A1, A2 Turkish language proficiency levels shall be granted 1-year leave of absence in order for them to increase this level. Those who do not submit the certificate proving C1, C2 or B1, B2 level of Turkish Proficiency at the end of one year or are not successful at the Turkish Proficiency Exam conducted by NÜTÖMER *shall be granted an extension of one year.*

## **PART FOUR**

### **Miscellaneous and Final Provisions**

#### **Other Provisions**

**ARTICLE 16-** (1) Foreign students shall be subject to the provisions of Niğde University Directive on Associate and Undergraduate Education and Training and Examination.

#### **Validity**

**ARTICLE 17-** (1) This directive is valid as of the date of its promulgation.

#### **Execution**

**ARTICLE 18-** (1) Provisions of this directive shall be executed by the Rector of Niğde University.
