REQUIRED DOCUMENTS FOR THE REGISTRATION

1	Original high school diploma and "equivalency certificate" (it will be obtained from Turkish Embassy or consulate or Ministry of National Education of Turkish Republic) showing that the diploma is equivalent to diplomas given by Turkish high schools.
2	The document confirming that the canditate has completed the last three year of high school education abroad (Turkish citizens)
3	Certificate of identity register copy from those who have dual citizenships, who have a blue card, and who have Republic of Turkey citizenships (those who have dual citizenships and have received their education in Turkey are required to provide a document which proves that their main citizenship is not Republic of Turkey)
4	Original transcript and a copy of it in English or Turkish, approved by the Turkish Embassy or Consulate in their countries.
5	Passport With Study Visa (Certified Turkish Translation By The Turkish Consulate/Embassy In Your Country) The students that come to Turkey by taking visa or visa exemption and reside in the country with a residence permit shall not be subject to the visa requirement when they become entitled to have education at Undergraduate/Associate degree levels of our University.
6	6 Passport Photographs
7	Payment Receipt Of Study Fee
8	A copy of Foreign Language-Turkish competency document valid internationally and approved by the Turkish Embassy or Consulate
9	Original passport and an approved copy of it which is translated into Turkish.
10	Application for candidates who declared during the examination result of the original certificate of examination results. (International Examination, National University Entrance Examination, and the result of foreign students' admission exam result of the universities in Turkey / YÖS)
11	"The previous year exam result score paper which show that the score is equal or higher than the placed programme's base score will be certified by the the applicants who apply with Higher Education Transfer Examination (YGS) / License Placement Examination (LYS). LYS or YGS exam result certificate will be indicated by the candidates."

Registration must be made in person by the student himself/herself. International student registration can not be accepted with the notary power of attorney.

NOTE

- 1- DURING THE APPLICATION DECLARATION, IF THE FALSE STATEMENT/DOCUMENT or INFORMATION INCORRECT REFERENCE DOCUMENT IS DETECTED THE CANDIDATE WILL LOSE REGISTRATION RIGHT EVEN IF PLACED.
- 2-THE REGISTRATION WILL NOT BE MADE WITH THE MISSING / INCOMPLETE DOCUMENTS, and THE CANDIDATES WHO HAVE MISSING/ INCOMPLETE DOCUMENTS WILL LOSE THEIR RIGHTS
- 3-THE CANDIDATES WHOSE APPLICATIONS HAVE BEEN ACCEPTED AND DESERVED THE RIGHT FOR THE REGISTRATION WILL APPLY FOR THE REGISTRATION ISSUES PERSONALLY. WITH THE NOTATER CONSENT, THE REGISTRATION ISSUES WILL NOT BE PERMITTED
