In accordance with the articles 8/(2)(k) of the "Niğde Ömer Halisdemir University Postgraduate Education-Teaching and Examination Regulation" and 5, 6, 7, 8 and 9 of the "Niğde Ömer Halisdemir University Postgraduate Programs Admission Directive", our University's Health Sciences Institute will admit international students to the Master's Programs of the Departments specified below in the Fall Semester of the 2025-2026 Academic Year.

**Documents Required from Candidates Applying to Thesis-Based Master's Programs:**

- 1- For master's programs, a copy of the undergraduate diploma or graduation certificate approved by a foreign representative and its approved Turkish translation,**
- 2- A copy of the transcript and its approved Turkish translation,**

**Application Requirements for Thesis-Based Master's Programs:**

**(1) Graduates of undergraduate or graduate programs of universities;**

**a) Those who were citizens of a foreign country but later acquired citizenship and became citizens of the Republic of Turkey or those who have dual citizenship in this situation,**

**b) Those who are citizens of the Republic of Turkey and completed their entire undergraduate education in a foreign country,**

**c) Those who are citizens of a foreign country can apply as international students.**

**(2) The institutions from which the candidates graduated must be recognized by the Council of Higher Education. Students who graduated from institutions that are not recognized by the Council of Higher Education will be dismissed from the relevant Institute even if they have registered.**

**Evaluation of Applications for Thesis-Based Master's Programs:**

**(1) Application files of candidates applying to graduate programs are evaluated by the relevant program's department board and evaluation results, together with justifications, are sent to the institutes with the decision of the department board. The**

acceptance of candidates deemed qualified to graduate programs is finalized with the approval of the EYK.

(2) Candidates who apply to the relevant institute based on bilateral agreements to which the university is a party and candidates who apply directly to the department/related department faculty member may be accepted to graduate programs as students outside the quota with the decision of the department board and the approval of the EYK. Candidates whose applications are accepted must complete final registration and course registration procedures on the dates announced on the institute's website in the following semester.

(3) The YÖK's grade conversion table is taken as the basis for the 100 system equivalents of the grade point averages of candidates whose graduation grade point averages are arranged according to the four-point system.

(4) The Turkish proficiency of candidates registered to programs where the language of instruction is Turkish, except for those who have obtained a Turkish C1 level certificate from TÖMER, NÖHÜTÖMER or Yunus Emre Institute and those who have graduated from a higher education institution in Turkey, is evaluated by NÖHÜTÖMER. Candidates whose Turkish language proficiency is insufficient are granted a two-semester leave to learn Turkish. At the end of this period, those who have obtained a C1 level Turkish Proficiency Certificate submit their documents to the Institute at the beginning of the relevant semester and begin their education. Students who are granted a leave of absence who cannot submit a C1 level Turkish Proficiency Certificate at the end of the given period or who fail the Turkish proficiency exam to be conducted by NÖHÜTÖMER are granted an additional two semesters. At the end of the additional period, students whose Turkish proficiency is deemed insufficient are dismissed from the relevant Institute.

(5) A compulsory foreign language preparatory program is applied to students who enroll in postgraduate programs that provide education and training in a foreign language. The provisions of the Niğde Ömer Halisdemir University Foreign Languages School Preparatory Program Education, Training and Examination Regulation apply to the compulsory preparatory program.

(6) Applications of candidates who do not meet the application requirements will not be evaluated.

#### **Announcement of Results and Final Registration:**

1- Application results are announced on the Institute's website.

2- The Institute sends an acceptance letter to candidates who are eligible to register.

3- Registrations are made by the Institute's Student Affairs Unit on the dates announced on the Institute's website.

4- If the student is not exempted from tuition fees through bilateral agreements, he/she is obliged to pay the tuition fee determined by the University Board of Directors within the framework of the Council of Ministers Decision.

#### **Documents Required for Final Registration:**

1) Final registration form,

2) Original document with certified copy of diploma or graduation certificate translated into Turkish by sworn translators,

- 3) Original document with certified copy of transcript translated into Turkish by sworn translators,
- 4) Certified copy of passport,
- 5) Six photographs taken within the last six months,
- 6) General Health Insurance (GSS) document from Social Security Institution,
- 7) Document showing that tuition fee has been paid, (According to the decision of our University Board of Directors dated 28/05/2025 and numbered 2025/162, tuition fee is 10,641 TL.

- ❖ If the documents requested from students who have earned the right to final registration are missing, students cannot register..
- ❖ If a student cannot obtain a residence permit for educational purposes from the Provincial Directorate of Immigration Administration with a student certificate after final registration, his/her registration will be cancelled.
