The General Consulate of Spain presents its compliments to the Ministry of Foreign Affairs of the Republic of Turkey and has the honor to inform that:

The Order issued by the Ministry of Interior of Spain INT/657/2020 on July 17th, last time modified by the Order INT/161/2021 from February 24<sup>th</sup> states in its Art. 1.1.f) that they will allow to enter Spain "Students to attend courses in the Member States or Schengen Associate States with student travel permit or student visa and health insurance, given that they travel to the country where the courses will take place and the entry will be during the courses or less than 15 days before the start".

In all cases, the students must submit to the border authorities on arrival to Spain, documents to proof that they are registered in the educational Centre (University, School) and Health Insurance.

If the stay is for more than 90 days, they will need to have the Student visa or Student residence permit in advance.

If the stay is for less than 90 days and when the classes are "face-to-face", they will need to travel with a Schengen Visa.

If they do not need a visa (Turkish citizens with Special or Service Passports and other nationalities who do not need a visa) they only documents required will be the proof that they are registered in the Educational Centre (University, School) and Health Insurance.

The General Consulate of Spain avails itself of this opportunity to renew to the Ministry of Foreign Affairs of the Republic of Turkey the assurances of its highest consideration.
